

How do I apply for admission to Cape Fear Community College?

1. Complete an online application at <http://cfcc.edu/admissions/#Process>. **NOTE:** An application **must** be on file **prior** to placement testing and registration. Applications should be submitted at least two weeks prior to registration. Check the Academic Calendar on the CFCC website for upcoming registration dates.
2. Request *official* transcripts from high school or equivalent from an accredited institution recognized by the Department of Education. High school/Equivalent transcripts must indicate the date graduated. *Official* transcripts are those received either by mail, by hand-delivery to CFCC in the original, sealed envelope from the awarding institution or agency, or electronically submitted via Parchment or eScrip-Safe. North Carolina public high school graduates may request their official high school transcripts be sent electronically to the Admissions Office via the College Foundation of North Carolina (CFNC) website at www.cfnc.org. Home schooled students must submit a copy of the home school's approved registration from the state in which they are registered (if applicable) and an official transcript of all high school courses, grades, graduation date, and unweighted GPA.
3. Take the **Placement** test, if applicable, by registering for a test date on the web page www.cfcc.edu/testing/schedule/. Applicants to degree, diploma, and certain certificate programs are required to have placement test scores on file prior to being accepted at CFCC. The test is given several times each month, free of charge to CFCC applicants with a photo ID, at both campuses. CFCC will accept *official* copies of placement tests taken at other colleges (**ASSET, COMPASS, ACCUPLACER**). Placement testing may be waived with official **SAT** or **ACT** results meeting the minimum scores listed below. Score reports must be mailed directly from the College Board or ACT. Contact College Board (SAT) at 866-756-7346, CFCC Code **5094**), or American College Testing (ACT) at 1-319-337-1000 (CFCC Code **3185**). The placement test may not be necessary if the applicant meets one or more of the following requirements:
 - A NC high school graduation date less than 5 years old with an unweighted GPA of 2.6 or higher and the successful completion of specific math coursework (beginning Fall 2016)
 - Successful completion of comparable writing and reading and/or math developmental courses at a school in the North Carolina Community College System. Consult with a counselor in U-240 for possible credit.
 - Achieved CFCC's cut-off scores for desired curriculum programs by submitting official **ASSET, COMPASS** or **ACCUPLACER (CPT)** scores taken within the last five years
 - Achieved the following minimum scores within the last five years: SAT Reading OR Writing – 500 (Prior to March 2016); SAT Evidence-Based Reading/Writing 480 (Tested March 2016 and Future); ACT Reading – 22 or English – 18; SAT Math 500 (Prior to March 2016); Math 530 (Tested March 2016 and Future) or ACT Math – 22; and has submitted an official copy to the Admissions Office.
 - Satisfactorily completed a college-level transferrable English Composition and/or Mathematics course above the developmental level at a regionally accredited college or university

Upon completion of the above steps, you will receive an acceptance letter. All new students are required to attend/view a New Student Orientation presentation. Early acceptance will enable you to take advantage of registration priorities.
