***Special Note**

Effective fall of 2016, **MAT 272-Calculus II** may be used as a UGETC math in the Associate in Science, Associate in General Education, and Associate in Fine Arts: Theatre programs. The course may not be used as a UGETC math in the Associate in Arts program. The statewide Transfer Advisory Committee was not able to secure additional math selections with the UNC faculty.

Transfer Programs Deleted from the Catalog

The transfer programs below will be deleted from the CFCC catalog, effective fall of 2016. Students who are continuously enrolled in these programs may complete the programs:

- ◆ Associate in Fine Arts: Art (Program Code: A1020A)
- ◆ Associate in Fine Arts: Drama (Program Code: A1020C)
- ◆ Associate in Fine Arts: Music/Music Education (Program Code: A1020D).

New Transfer Programs

The transfer programs below will be implemented fall of 2016:

- ◆ Associate in Fine Arts: Visual Arts (Program Code: A10600) = 60-61 SHC
- ◆ Associate in Fine Arts: Music (A10700) = 64-65 SHC
- ◆ Associate in Fine Arts: Theatre (A10800) = 60-61 SHC.

How are these new programs an improvement over for the old programs?

The justifications are as follows:

- ◆ There is better alignment with the senior institution's baccalaureate plan.
- ◆ There is better alignment with the standards in the Associate in Arts, the Associate in Science, and the Associate in Engineering programs.
- ◆ The increased use of the UGETC courses in the Associate in Fine Arts: Visual Arts and the Associate in Fine Arts: Theatre programs help make the transfer process easier for students. These two programs require only 60 hours each.
- ◆ The program title revisions assist in clarifying the program content and provide more consistency with the baccalaureate plans.

Placement Testing News

Placement Test Advising Guide

Applicants entering vocational/technical and college transfer courses must begin their English sequence with the course corresponding to their score levels on the following placement tests.

ENGLISH PLACEMENT

Testing is not required with
SAT Reading 500 or Writing 500

OR

ACT Reading 22 or English 18

OR

Transfer credit of ENG 111 or its equivalent with a grade of "C" or better.

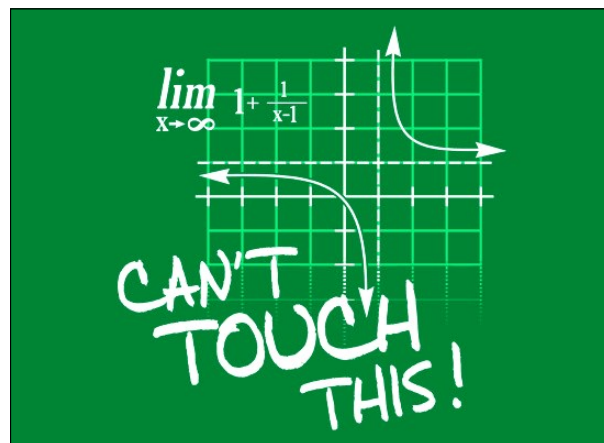

Calculus I Placement

A student may place directly into MAT 271 if the student has met at least one (1) of the following criteria within the past five (5) years:

- ◆ A score of 2 or higher on the AP Calculus AB Exam.
- ◆ A grade of C or higher in an AP Calculus course and an unweighted HS GPA of 3.0 or higher.
- ◆ A score of 90 or higher on the ACCUPLACER College-Level Math (CLM) test.
- ◆ A score of 46 or higher on the trigonometry section of the ACT Compass Math Placement Test.
- ◆ A score of 580 or higher on the SAT Math and a grade of C or higher in the North Carolina Standard Course of Study Pre-Calculus course or an equivalent course from another state.
- ◆ A score of 27 or higher on the ACT Math and a grade of C or higher in the North Carolina Standard Course of Study Pre-Calculus course or an equivalent course from another state.
- ◆ A score of 560 or higher on the SAT Subject Test in Mathematics Level 2.



Business Office News

Students' classes **ARE NOT** automatically purged (deleted from the system). Unfortunately, the purge does not pick up everyone, especially financial aid students. Every semester, there are students who are reported as No Shows (as never having attended class), lose their financial aid, and end up with a debt owed to the college. If students are not going to attend CFCC, for whatever reason (example: No financial aid and not able to pay out-of-pocket), they should drop their classes themselves and not wait to be purged.

This message is also on the WebAdvisor page:

Drop your classes if you decide not to attend.

Students who choose not to attend a class or all of their classes are **responsible for withdrawing themselves** to avoid being charged and receiving a No Show for the class. This includes completing the forms, obtaining appropriate signatures and returning them to the appropriate place.

A pre-registered curriculum student who officially drops from any/or all classes prior to the first day of the College's academic semester will be eligible for a 100 percent tuition refund.

A pre-registered curriculum student who officially drops from any/or all classes during the period starting from the first day and ending on the 10% day of the academic semester, will be eligible for a 75 percent tuition refund.

Students may drop classes online using WebAdvisor or may complete a drop card in-person at the Registrar's Office at either campus. Once classes start, access to WebAdvisor is no longer available for any registration/drop activity. All drops **will need to be done in-person at the Registrar's Office after classes start**. The effective date of the drop is the day the Registrar's Office receives the form.

4. Review information and click “OK” if it is correct.

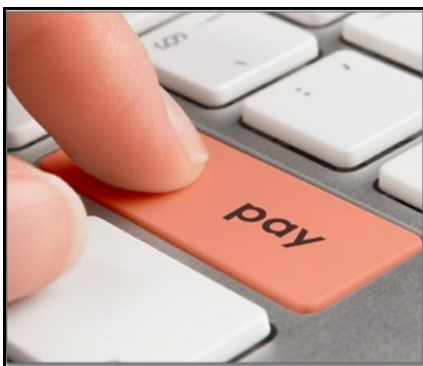


Parking Decals

Decals, along with rules/regulations, may be obtained from the Cashier’s Office at either campus. You must provide your vehicle information, including license plate number, in order to obtain a decal. You must always display your parking decal in your vehicle, even if your vehicle is parked inside the parking deck.

Social Security Numbers, Reliable Addresses, and Current Telephone Numbers

It is important for CFCC to correspond with you! Please make sure that the College has your current address and telephone number. The Business Office must mail refund checks, tax statements, and other important correspondence to students; but items are constantly returned because some students do not update their information. Social Security Numbers are used for information returns and are necessary for processing financial aid.



Tuition Payment Plan

CFCC offers a convenient monthly Tuition Payment Plan (FACTS) to help students meet their educational expenses. This service is provided by Nelnet Business Solutions. The cost to enroll is a \$25.00 per semester, non-refundable enrollment fee. The enrollment fee and applicable down payment are processed immediately from your bank account/credit card. Any remaining payments will be automatically deducted on your scheduled payment dates.
