- DUI/DWI - open DUI/DWI cases are unable to attend our Truck Driver Training Program
- Drug Possession Convictions
- Moving Violations (ex. Speeding, Improper Lane Change, etc.)
- Reckless Driving Violations
- Preventable Accidents
- Refusal to take a chemical test

### **COURSE DESCRIPTION**

- Truck Driver Training is designed to prepare individuals to drive tractor-trailers rigs. This program teaches proper driving procedures, safe driver responsibility, commercial motor vehicle laws and regulations, and the basic principles and practices for operating commercial vehicles.
- The coursework includes motor vehicle laws and regulations, map reading, vehicle maintenance, safety procedures, daily logs, defensive driving, freight handling, security, and fire protection. Highway driving, training range exercises, and classroom lectures are used to develop the student's knowledge and skills.
- Graduates of the curriculum are qualified to take the Commercial Driver's License Exam and gain employment with commercial trucking firms. They may also become owner-operators and work as private contract haulers.
- Our goal is to prepare students for job entry, advancement and independence with emphasis placed on:
  - Motor Carriers Safety Regulations
  - Safety Inspections
  - Vehicle Maintenance
  - Range Maneuvers
  - Defensive Driving
  - Over-the-Road Driving
  - Hours of Service
  - Trip Planning
  - Cargo Handling
- Day & evening classes are offered. The day class runs 8 weeks and the evening class runs 10 weeks. Inclement weather may affect the daily schedule.
- The class is 434 hours with approximately 80% of class time spent on the range/road and approximately 20% hours in the classroom including online learning. Students will need access to a computer, laptop or tablet to complete the course.

### **REQUIREMENTS**

- Must be 18 years of age
- Must have a valid Driver's License (we do accept out-of-state licenses)
- Must be able to read, write and speak English well enough to converse and follow directions of law enforcement

## REQUIRED DOCUMENTS NEEDED BY THE FIRST DAY/NIGHT OF CLASS

1) **Obtain your CDL Class A Permit with Tanker Endorsement:** Study sections 1, 2, 3, 5, 6, and Tanker in the DMV Driver's Manual. Take the following multiple choice tests at the DMV: General Knowledge, Combination Vehicles, Air Brakes and Tanker Endorsement.

2) **DOT Physical:** Schedule an appointment with your healthcare provider or local urgent care for a DOT Physical. Be sure you receive the Medical Certificate page. We recommend any Medac location.

### **NO MORE THAN 30 DAYS PRIOR TO CLASS DO THE FOLLOWING:**

3) **DOT Drug Screen:** Visit your local urgent care & ask for a DOT 5 Panel Drug Screen. We recommend any Medac location. ***This is in addition to your physical. It is not the urine sample taken at the time of your physical. DO NOT go less than 7 days prior to the start of class. Results MUST be received by the start of class in order to stay enrolled.***

4) **DMV Driving Record:** Download/Screenshot your **non-certified** DMV Driving Record **AFTER** you've passed your permit tests. <https://payments.ncdot.gov/>

**Once you've completed the above, send copies of all these documents AND your Driver's License to [truckdriver@cfcc.edu](mailto:truckdriver@cfcc.edu) or fax them to 910-362-7494.**

**If these documents are not received by the start of class you will not be permitted to begin class.**

**You will be transferred to the following class or can request a refund.**

**For a 100% refund, requests must be received before class starts.**
